# 2. Deed Restriction updates/items for 2024 Ballot:

- President Carla Williams made a motion that deed restriction #8 be updated to read No used material may be used in the construction of any structure in the subdivision without prior approval and inspection from the ACC and Board of Directors. Vice President Robert McKenzie seconded motion. Motion Passed.
- President Carla Williams made a motion that deed restriction #9 be updated to read No used house, travel trailer, RV or other building may be moved onto any lot in said subdivision without prior approval and inspection from the ACC and Board of Directors. Vice President Robert McKenzie seconded motion. Motion Passed.
- President Carla Williams made a motion that deed restriction #14 be updated to read No livestock shall be staked or pastured on any lot. No animals, livestock or poultry of any kind shall be raised, or bred or kept on any lot, except that no more than 4 dogs and 4 cats with vaccination records, or other household pets may be kept, provided they are not bred, kept or maintained for any commercial purpose and solely as pets. Member at Large Tom Morgan seconded. Motion Passed.
- President Carla Williams made a motion that deed restriction #17 be updated to read Swimming pools, park and launching ramps are for the sole use and benefit of property owners and their guests. Property owners will be responsible for their guests. Association, nor Board of Directors does not assume any liability for theft, loss, damage, or injuries sustained. Member at Large Tom Morgan seconded. Motion Passed.
- President Carla Williams made a motion to add increasing Association Fees to \$45.00 per lot to ballot for vote. Secretary/Treasurer Sandy Frick seconded. Motion Passed.
